CUTTING SPECIFICATION:

A STANDARD SEVEN RIB RIB EYE ROLL IS DERIVED FROM A RIBSET BY THE REMOVAL OF THE RIB ENDS LEVEL WITH THE EYE MUSCLE MASS . ENSURE THAT THE CUBE ROLL IS REMOVED FROM THE FOREQUARTER WITH BOTH CRANIAL AND CAUDAL ENDS CUT SQUARE.

PACKING SPECIFICATION:

ENSURE LOOSE PARTICLES OF MEAT AND FAT ARE REMOVED BEFORE PLACING INTO VACUUM BAG.PACK DORSAL EDGE TO BOTTOM OF CARTON.ENSURE NEAT PRESENTATION.

TRIMMING SPECIFICATION:

FAT ON THE DORSAL EDGE MUST BE TRIMMED LEVEL WITH THE MEAT SURFACE. AVOID MUSCLE SEPARATION DURING TRIMMING.FAT ON REMAINING SURFACES MUST BE TRIMMED SO AS TO GIVE SMOOTH AND EVEN APPEARANCE ENSURE RAGGED PIECES OF MEAT AND FAT ARE REMOVED.
