MINI CEREAL FLUTE: WHEAT flour, water, cereals and seeds mix (flaxseed 2,7% (golden and brown), sunflower seeds 1,1%, SESAM 1,7% (peeled, roasted), RYE flakes, OAT flakes, pumpkin seed 0,5%), salt, yeast, roasted WHEAT malt flour, emulsifiers (E472e).
